

**GRAND COUNTY RESOLUTION NO. 3391
CITY OF MOAB RESOLUTION NO. 27-2024**

**ADOPTING A JOINT RESOLUTION OF THE CITY OF MOAB AND GRAND COUNTY
APPROVING A MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN THE CITY OF
MOAB AND GRAND COUNTY FOR COOPERATION IN THE SITE ANALYSIS,
PRELIMINARY PLANNING, AND MASTER PLANNING EFFORTS RELATED TO ATLAS
PARK**

WHEREAS, the City of Moab ("Moab") and Grand County ("County") recognize the significance of the Uranium Mill Tailings Remedial Action or "ATLAS" site (the "Site") as a vital resource for the community and its potential for future development after the DOE finishes remediation; and

WHEREAS, Moab and the County are committed to a collaborative effort in the comprehensive site analysis, preliminary planning, and master planning of the site to ensure its successful redevelopment and transfer from the Department of Energy ("DOE") to local control and public use; and

WHEREAS, Moab and the County have developed a Memorandum of Understanding ("MOU") to establish a framework for cooperation that outlines their respective roles, responsibilities, and commitments with respect to the prospective Site planning process; and

WHEREAS, the MOU describes the joint effort in planning, the assignment of a dedicated employee to serve as the Special Project Coordinator, and the creation of a reporting structure to ensure efficient communication and progress monitoring; and

WHEREAS, the Moab City Council and Grand County Commission desire to formally adopt the MOU and authorize their respective representatives to sign the agreement on behalf of the City and County;

NOW, THEREFORE, BE IT RESOLVED by the City Council of Moab and the Board of County Commissioners of Grand County:

1. Approval of the MOU. The City of Moab and Grand County hereby approve the MOU between Moab and the County for cooperation in the site analysis, preliminary planning, and master planning efforts for the Site, a copy of which is attached hereto as Exhibit A and incorporated herein by reference.


2. Authorization to Sign. The Mayor of the City of Moab and the Chair of the Grand County Board of Commissioners are hereby authorized to execute the MOU on behalf of their respective entities.

3. Implementation of the MOU. Upon execution of the MOU, the Moab and Grand County authorize and direct their staff and agents to take all necessary steps to implement the terms and conditions outlined in the MOU, including the hiring of the Special Project Coordinator by Moab, the allocation of resources, and participation in regular meetings as specified.

4. Effective Date. This Resolution shall be effective immediately upon its passage by the City Council of Moab and the Board of County Commissioners of Grand County.


